

## REQUEST FOR SUPPORT BY PENNSYLVANIA UNIVERSALIST CONVENTION

**Project Name & Description:** Anti-Racism Anti-Oppression Multicultural Collaboration  
Part of the mission of the PUC is to foster the exchange of program ideas with other congregations and to promote the importance of our Universalist Heritage. We would like to hold two events in partnership with our neighboring Philadelphia UU churches, Unitarian Society of Germantown and First Unitarian Church of Philadelphia in Center City. Both churches have expressed an interest in joining with us to become more anti-racist and more anti-oppressive. We propose to hold a Jubilee One training at UUCR and invite members and friends of USG and First Church. In conversation with former moderator Barbara Bunkle, Paula Cole Jones, a UUA diversity consultant, suggested that UUCR members and friends would benefit from a Beyond Categorical Thinking workshop. The UUA encourages congregations who are searching for a settled minister to hold this training for their members and their search committees. Ms. Cole Jones believes it would be a valuable way for people who have attended Jubilee workshops and Welcoming Congregation workshops to sharpen their understanding and extend their thinking about privilege and difference along the lines of race, gender, and sexuality. While we are completing our Welcoming Congregation efforts this year, Reverend McCall has stated many times that to be truly welcoming requires an ongoing conversation and continuing education about anti-oppression topics. Not many churches have incorporated these workshops about race and GLBTQ issues as points of continuing education and discussion within a congregation.

With funding from the PUC, we could demonstrate leadership in this area. We can invite workshops leaders trained by the UUA to present these two workshops to UUCR, USG, and First Church. A grant request of \$1,500, along with contributions from those attending, should cover the workshop fees, transportation costs, and some scholarship funds so that registration fees would not become a barrier.

**Period covered:** April 1, 2007 through March 31, 2008

**This is standard, as it conforms to the PUC fiscal year.**

**Dates(s) funds required:** Half when the event is scheduled and balance after event

**This is where we request how the grant money is to be sent to us. Some grants, like staff support and ministerial support, are requested in four quarterly payments. Since the Uncommon Denomination was to include regular advertising, we asked for four quarterly payments. Other grant requests, like the audio-visual request, ask for imbursement with receipt after the items have been purchased or the services contracted.**

**Membership count:** 93  
As reported to the UUA in January.

**Cost per member per year:** \$16.13

(\$1,500.00/93=\$16.13)

**Expected results of project:** Two events that would provide opportunities for adults to learn about diversity. An opportunity for members to share experiences with members from other churches.
